Milwaukee, WI - September 10, 2020 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of August 31, 2020 totaled \$136.5 billion. Separate accounts¹ accounted for \$73.3 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$63.2 billion.
