

## Artisan Partners Asset Management Inc. Reports August 2025 Assets Under Management

Milwaukee, WI - September 10, 2025 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of August 31, 2025 totaled \$178.1 billion. Artisan Funds and Artisan Global Funds accounted for \$87.0 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$91.1 billion.
