## Artisan Partners Asset Management Inc. Reports April 2026 Assets Under Management

Milwaukee, WI - May 11, 2026 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of April 30, 2026 totaled \$183.0 billion. Artisan Funds and Artisan Global Funds accounted for \$89.1 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$93.9 billion.
