## Artisan Partners Asset Management Inc. Reports January 2020 Assets Under Management

Milwaukee, WI - February 11, 2020 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of January 31, 2020 totaled \$120.2 billion. Separate accounts<sup>1</sup> accounted for \$63.2 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$57.0 billion. In the month of January, AUM decreased \$811 million primarily due to negative investment returns and slight net outflows.
