## Artisan Partners Asset Management Inc. Reports September 2023 Assets Under Management

Milwaukee, WI - October 10, 2023 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of September 30, 2023 totaled \$136.5 billion. Artisan Funds and Artisan Global Funds accounted for \$66.6 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$69.9 billion.
