

## Artisan Partners Asset Management Inc. Reports August 2020 Assets Under Management

Milwaukee, WI - September 10, 2020 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of August 31, 2020 totaled \$136.5 billion. Separate accounts<sup>1</sup> accounted for \$73.3 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$63.2 billion.
