## Artisan Partners Asset Management Inc. Reports March 2026 Assets Under Management

Milwaukee, WI - April 10, 2026 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of March 31, 2026 totaled \$173.0 billion. Artisan Funds and Artisan Global Funds accounted for \$84.5 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$88.5 billion.
