



## Artisan Partners Asset Management Inc. Reports November 2019 Assets Under Management

Milwaukee, WI - December 10, 2019 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of November 30, 2019 totaled \$117.1 billion. Separate accounts<sup>1</sup> accounted for \$62.0 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$55.1 billion.
