## Artisan Partners Asset Management Inc. Reports February 2026 Assets Under Management

Milwaukee, WI - March 10, 2026 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of February 28, 2026 totaled \$188.5 billion. Artisan Funds and Artisan Global Funds accounted for \$92.4 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$96.1 billion.
