

## Artisan Partners Asset Management Inc. Reports August 2018 Assets Under Management

Milwaukee, WI - September 12, 2018 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of August 31, 2018 totaled \$117.4 billion. Separate accounts<sup>1</sup> accounted for \$58.8 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$58.6 billion.
