

## Artisan Partners Asset Management Inc. Reports July 2018 Assets Under Management

Milwaukee, WI - August 9, 2018 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of July 31, 2018 totaled \$117.1 billion. Separate accounts<sup>1</sup> accounted for \$58.9 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$58.2 billion.
