## Artisan Partners Asset Management Inc. Reports August 2022 Assets Under Management

Milwaukee, WI - September 12, 2022 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of August 31, 2022 totaled \$132.7 billion. Artisan Funds and Artisan Global Funds accounted for \$63.5 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$69.2 billion.
