## Artisan Partners Asset Management Inc. Reports May 2020 Assets Under Management

Milwaukee, WI - June 9, 2020 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of May 31, 2020 totaled \$114.4 billion. Separate accounts<sup>1</sup> accounted for \$60.7 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$53.7 billion.
