## Artisan Partners Asset Management Inc. Reports October 2019 Assets Under Management

Milwaukee, WI - November 11, 2019 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of October 31, 2019 totaled \$114.5 billion. Separate accounts<sup>1</sup> accounted for \$60.1 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$54.4 billion.
