## Artisan Partners Asset Management Inc. Reports January 2026 Assets Under Management

Milwaukee, WI - February 10, 2026 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of January 31, 2026 totaled \$185.3 billion. Artisan Funds and Artisan Global Funds accounted for \$90.2 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$95.1 billion.
