## Artisan Partners Asset Management Inc. Reports June 2025 Assets Under Management

Milwaukee, WI - July 10, 2025 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of June 30, 2025 totaled \$175.5 billion. Artisan Funds and Artisan Global Funds accounted for \$85.6 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$89.9 billion.
