## Artisan Partners Asset Management Inc. Reports April 2023 Assets Under Management

Milwaukee, WI - May 9, 2023 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of April 30, 2023 totaled \$138.4 billion. Artisan Funds and Artisan Global Funds accounted for \$66.9 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$71.5 billion.
