## Artisan Partners Asset Management Inc. Reports September 2019 Assets Under Management

Milwaukee, WI - October 9, 2019 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its assets under management ("AUM") as of September 30, 2019 totaled \$112.5 billion. Separate accounts<sup>1</sup> accounted for \$59.1 billion of total firm AUM, while Artisan Funds and Artisan Global Funds accounted for \$53.4 billion.
