

## Artisan Partners Asset Management Inc. Reports May 2025 Assets Under Management

Milwaukee, WI - June 10, 2025 - Artisan Partners Asset Management Inc. (NYSE: APAM) today reported that its preliminary assets under management ("AUM") as of May 31, 2025 totaled \$170.9 billion. Artisan Funds and Artisan Global Funds accounted for \$83.4 billion of total firm AUM, while separate accounts and other AUM<sup>1</sup> accounted for \$87.5 billion.
